The Children's Trust becomes the only children's charity accredited to ISO9001 by CHKS in the UK

Following assessment by a team of external senior healthcare professionals, trained as peer review surveyors, <u>The Children's Trust</u> has been accredited ISO9001 by CHKS. The CHKS standards cover the core principles of healthcare delivery including patient safety, quality improvement, leadership, governance and effective management, developing staff and managing risk.

ISO9001 status provides a framework for quality assurance and quality improvement. Taking part in the process of accreditation gives an organisation credible and independent recognition of the organisation's commitment to quality improvement for the children and families who use our service, Board and external regulators.

In the CHKS report, the assessors highlighted the following for special commendation:

- How children and young people using the service have been consulted and involved in the review of written information for how to make a complaint or comment
- A poster presentation being accepted for an international conference, sharing results and seeking feedback from children and young people who had used the service
- The branding, design and language used on information, media and signage which reflects the passion displayed by the organisation's staff

- Child-friendly name badges as well as formal identification badges
- The great deal of work undertaken to obtain feedback from the children and young people using the service
